Chairs report inc secretary's report

Treasurer's report

The report was read and debated, it showed a small increase in funds over the year, event fees and club membership fees were discussed and agreed to remain at the previous years levels, with the proviso that the committee could increase fees for events were there was high costs, such as access.

Membership report

The membership report noted that we had 143 members vs 137 the previous year. 21 non-renewals and 27 new members mainly via the C2G course. The age distribution shows a big dip in the 35 - 45 range.

Mapping

The mapping report detailed the excellent work completed by the mapping team on many maps and the training ongoing to develop future mappers.

A comment was made to ensure planners were locating the latest map on the Google drive.

Club Development Officer

The CDO report was circulated and discussed. The continuation of the CDO role for another two years was debated. The role would only be funded for one year by the Orienteering Foundation. It was agreed by a majority to continue with the role and fund it without OF support, focusing on family events.

Schools Development officer

This report was circulated and reviewed. The amount of schools work appeared to be dropping, although an academy group was being partnered with the secure a large mapping job and the outdoor class room was being partnered with in the hope of additional resources and work.

Junior training

A report was circulated. The local level training had stopped as the number of young juniors requiring training outside of the NEJS was very low.
